## Richfield Bans Flavors, Caps Licenses at Four

On August 8, 2023, the Richfield City Council voted 3-0 to pass an ordinance that prohibits the sale of all flavored commercial tobacco products, including menthol, and caps the number of tobacco licenses at four. It is the 11th city or county in Minnesota to completely ban flavors, following closely behind its neighbors Bloomington and Edina.

The council heard from five testifiers in support of the ordinance at the August 8th meeting. American Heart Association advocate Mark Olson shared how he got involved in tobacco prevention after having a heart attack 16 years ago. In response to the pro-business arguments against the ordinance, Mark said, "I

LOCAL CANNABIS ACTION: HOW CITIES ARE RESPONDING TO LEGALIZATION want kids to be able to live the American Dream...Without this ordinance, it's going to set them up to not even be living to do that." Councilmember Hayford Oleary dubbed this quote "a pretty perfect line" later in the meeting.

Councilmember Hayford Oleary also read a statement from Councilmember Whalen, who could not attend the meeting. Whalen explained his rationale for supporting the ordinance, writing "...banning the sale of flavored tobacco products plus limiting tobacco licenses over time makes sense as a way to prioritize public health."

After voting to pass the ordinance, Mayor Supple and Councilmembers Hayford Oleary and Christensen repeatedly emphasized the importance of choosing public health. The Council also mentioned that the city will be removing tobacco products from its municipal liquor stores. "I do recognize that this does have an effect on small business owners, so I think that is something that we do have to acknowledge here," noted Mayor Supple.

The ordinance takes effect on January 1, 2024.

# Mid Continent Management Corporation Launches Company-Wide Smoke-Free Policy

This fall, smoke-free air is the new normal at Mid Continent Management Corporation multi-family housing properties. As of September 1, 2023, a new smoke-free policy applies to all 39 properties and nearly 2,400 units across the Twin Cities metro area, protecting thousands of Minnesotans from toxic secondhand smoke in their homes.

Ongoing issues with the impact of secondhand tobacco smoke on resident wellness and property upkeep prompted Mid Continent Management Corporation's decision to go smoke free; , cannabis legalization in Minnesota and concerns about potential impacts of secondhand cannabis smoke accelerated policy implementation plans. Company leaders hope the new smoke-free policy will help create healthier, cleaner and safer environments for residents, guests and staff.

"Our goal at Mid Continent Management Corporation is to always do the right things by providing housing that supports our residents' wellbeing and safety. We want that for our staff and guests, too Coing smoke free was the obvious shoins aspecial

### Local Cannabis Action: How Cities are Responding to Legalization

With the Office of Cannabis Management (OCM) still in its early stages and adult cannabis use and possession legal as of August 1, 2023, local governments are taking advantage of the limited authority granted to them in state bill HF 100 to regulate cannabis at the city level. Cities are primarily concerned with three areas: public use, cannabis businesses and the sale of edible cannabinoid products.

**Public use:** In response to concerns about secondhand smoke and clean outdoor air, many cities have amended their city codes to prohibit the use of cannabis and hemp products in public places, including city parks.

Moratoriums on cannabis businesses: HF 100 gives local governments the authority to "adopt reasonable restrictions on the time, place, and manner of the operation of Cannabis Businesses," but also requires the OCM to work with local governments to develop model ordinances for these reasonable restrictions and to establish additional rules and regulations. Currently lacking this guidance, many cities have adopted an interim ordinance/moratorium prohibiting the operation of cannabis businesses until January 1, 2025 to protect the planning process and health of citizens while studying potential regulation measures.

**Edible cannabinoid products:** Many cities put one-year moratoriums in place last summer prohibiting the sale of edible cannabinoid products due to unexpected legalization and the general lack of direction from the state. Most of these moratoriums have expired, so cities are adopting ordinances to regulate the sale of these products and establish licensing requirements until the OCM assumes licensing of cannabis businesses.

### Youth Advocate Highlight: Kalia & Upendo

ANSR's work wouldn't be possible without the perspectives and efforts of young people. This summer, when youth advocates Kalia Vang and Upendo Gimbi weren't tabling together at outreach events, they were going above and beyond to engage their communities about commercial tobacco in other ways.

Upendo shared resources and swag items with her congregation at Holy Trinity Lutheran in Minneapolis to educate her Swahili-speaking community members about price discounting policy. Kalia serves on the Minnesota Department of Health's Youth Advisory Council and worked with other metro youth leaders on



flavored tobacco campaigns and peer education efforts this summer.

A big thank you to Upendo and Kalia for all of their work!

Youth advocates Kalia and Upendo tabled at multiple community outreach events this summer and are quite a team when collecting advocacy postcards.

Carol Bergh is a long-time supporter of ANSR and partner in fundraising efforts. As a former smoker, she readily advocates for local policy change by sharing about her firsthand experiences with smoking-related illness and secondhand smoke exposure. In 2019, Carol testified in front of the New Brighton City Council when the city passed an ordinance raising the tobacco sales age to 21. The policy protects young people in her hometown from tobacco's harms, and her voice helped it cross the finish line.

For Carol, flavored tobacco ordinances are a no-brainer. "Any time you can pass a ban that stops people from smoking, it's only helpful for the citizens," she says.

ANSR was lucky to have two fabulous interns on our team this summer. Gracyn Delaune is a third-year sociology student at Simmons University, and De'Marco Walton is a third-year communications student at the University of Minnesota-Twin Cities.
