Statement on AAPI Racism

May 2021

ANSR stands strongly with our staff, community partners, and all members of the Asian, Asian American, and Pacific Islander (AAPI) community, who are facing increased racism, xenophobic attacks, and bigotry. As an organization focused on tobacco prevention, public health policy change, and community education, ANSR recognizes our role in eliminating the health inequities that Asian American communities in Minnesota face including those due to decades of tobacco industry targeting. George Floyd Statement
